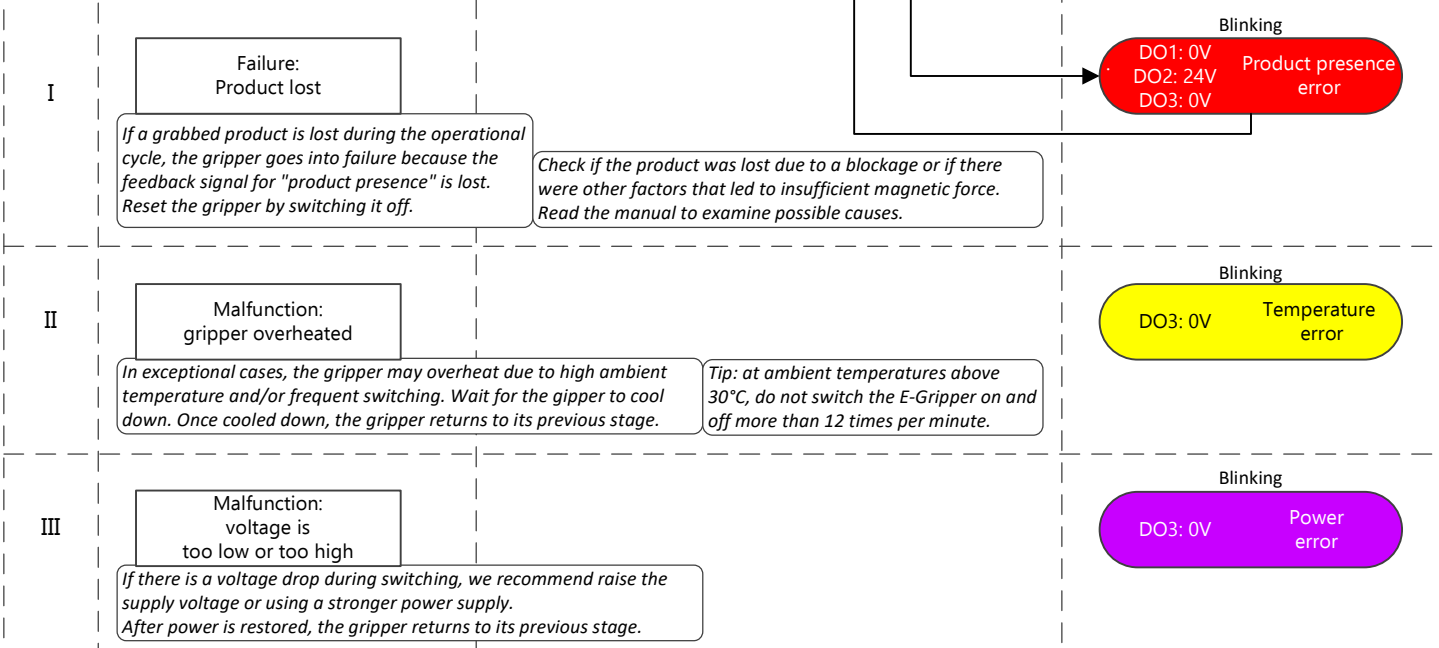


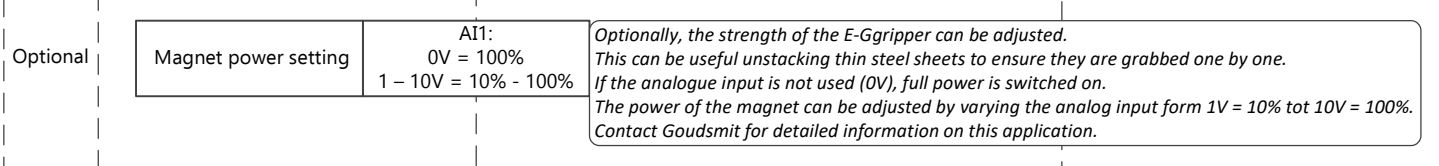
Operation flowchart E-Gripper

Stage	Operation & Input	Control logic for switch states	Output & light signals
A	Switch power ON Main: 24V	Initialization OK? Yes Magnet ON? No Product present? No	Varying colours Initialising or hardware error
B	Move gripper to workpiece <i>When the gripper is placed on a product and the light signal does not turn light blue, this may be due to too large air gap or too many perforations in the workpiece. Improve the gripper's touch to solve this problem.</i>	Yes Product present? Yes	<i>Magnet OFF, No product</i> DO1: 24V DO2: 24V Ready to start DO3: 24V
C	Switch gripper ON DI1: 24V/10ms pulse	Product present? Yes	<i>Magnet ON, product detected</i> DO1: 0V DO2: 0V Ready to move workpiece DO3: 24V
D	Move gripper to next location	No	
E	Switch gripper OFF DI2: 24V/10ms pulse		<i>Magnet OFF, product detected</i> DO1: 24V DO2: 0V Ready to grab DO3: 24V
